# **ANNUAL MEMBERSHIP RENEWAL FORM – 2020/21**

Fees are due by 30th June. You will be unfinancial if you do not renew within 1 month of the due date.

#### **NOTES:**

- 1. Club membership fees are set at the AGM in March and are due by 30th June.
- 2. This renewal form can be used for one or two members at the same address.
- 3. Use an additional form if there are more than 2 members at the same address.
- 4. Each member must annually accept the "Acknowledgement of Risk" and the "Privacy Statement", which can be done online or by signing the other page of this form. A responsible adult should do this on behalf of a Junior Member. If you don't accept the "Acknowledgement of Risk" you will not be covered by the Club's insurance policies.
- 5. Members who have not paid within one month of the due date will be considered unfinancial. Unfinancial members do not receive the Newsletter, may not participate in Club activities, and are not covered by our insurance policies.

## **Privacy Statement:**

Springwood Bushwalking Club Inc. is bound by the *Privacy Act 1988*. Club policy is to restrict the use of the personal details on this form to the committee, activity leaders and other club members for purposes directly associated with club administration and activities.

## Acknowledgement of Risk:

This Acknowledgement of Risk applies to all club activities I may undertake as a member of the Springwood Bushwalking Club. In voluntarily participating in the activity referred to on this Risk Waiver form and described to me by the Activity Leader I am aware that my participation in this Activity may expose me and any Junior Member I am responsible for, to risk that could lead to injury, illness or death or to loss of or damage to my/our property.

These risks may include but are not limited to injury from hazards which can be encountered whilst on this activity, including from: flora or fauna, slippery and/or uneven surfaces, rocks being dislodged, falling at edges of cliffs or drops or elsewhere, risks associated with crossing creeks, hypothermia and heat exhaustion. In particular when participating in abseiling or above the snowline activities I am aware that I may be exposed to additional hazards and risks. I also acknowledge that I may be in locations where evacuation for medical treatment may take hours or days.

I will make all reasonable effort to avoid or minimise these risks by:

- 1. only participating in activities within my capabilities,
- 2. carrying food, water and equipment appropriate for the activity,
- 3. advising the leader if I am taking any medication or have any physical or other limitation that might affect my participation in the activity.
- 4. making every effort to remain with the rest of the party during the activity,
- 5. advising the leader of any concerns I am having, and
- 6. complying with all reasonable instructions of the activity leader, and
- 7. not leaving the party before the conclusion of any activity, without the leader's prior knowledge and consent.

I have read or heard and understand these requirements. I have considered the risks before choosing to sign this form. I still wish to be a member of the Club. I agree by signing this form to waive any claim for damages arising from participation in a Club activity that I may have against the Club, the leader or other participants in tort or contract. I acknowledge that I will take responsibility for my own actions and will help others to complete the activity safely. I agree the above also applies for any junior member I am responsible for and have indicated this by signing this form on their behalf.
